

2.00 Subsequently, the Principal Chief Conservator of Forests (Wildlife) Maharashtra State vide office note No.2 has office comments are given below:-

*The proposed project passes through Great Indian Bustard Sanctuary. Hence, as per Wildlife (Protection) Act, 1972 and the guidelines of MoEF & CC regarding wildlife clearance proposal vide letter dated 21/07/2022, wildlife clearance would be necessary for the proposed project. As per the guidelines of MoEF&CC on linear projects (Wildlife clearance) animal passage plan is to be prepared along with the wildlife clearance proposal.*
