Sir,

Adverting to the above cited reference, the authentication of the DGPS raw data is accorded for a length of 7147.0 m or 7.147 km of the subject road stretch falling in the Forest area.

2. In this regard, it is submitted that the proposed work of widening the carriage way in the Forest area is in a length of 7.147 km. The length of the road which passes through the jurisdiction of Forest Divisional Officer, Chennur is in a length of 1.35494 km and that which passes through jurisdiction of Forest Divisional Officer, Mancherial is in a length of 5.79206 km.

3. The width required for widening is 20.00 m. The forest area required for diversion is 14.29 Ha. The break-up is given below:

I submit here with the Proposal for Diversion of Forest land in Mancherial District in 14 sets 7 sets each for FDO Mancherial and FDO Chennur Division for Widening and Strengthening of NH63 Mancherial - Chennur section, Chennur RF. The proposal has also been uploaded on the website. The above proposed diversion of forest land is for development of infrastructure belonging to Government of India.

5. In view of the above, Principal Conservator of Forests, Hyderabad is requested to accord approval to diversion of the Forest Land duly exempting from the provision of Non Forest Land for afforestation at an early date.
