It is to inform that, according to the Online application uploaded by the User Agency, the area required for diversion forest land for formation of road from Thimmalanmedu to Kotturmalai is 5.00ha. However, on verification of the KML file, it is found that, the area uploaded in the web portal is 1.975ha. Further it is also informed that, the area of Compensatory Afforestation land proposed for this case is 10.00ha. But the KML file the uploaded by the User Agency in the web portal is 9.12ha.


Hence, the User Agency is requested to upload the correct KML file for both diverted land and Compensatory Afforestation land for 5.00ha and 10.00ha respectively. After uploading the details, send a report immediately to enable this office along with the GPS Co-ordinates of the diverted land and Compensatory Afforestation land with road alimant sketch to forward the proposal to the Conservator of Forests without delay.
