Sub.: Diversion of 1.2 ha Reserved Forest land for the project of strengthening of construction of Jira-Hirava-Patala road (O.D.R.) Km. 0/00 to 9/500 (Working section 4/630 to 6/230) of Amreli District in favour of Executive Engineer, Panchayat (R&B) Division, Amreli.

Sir,

With reference to the above mentioned subject and letter under reference, I am directed to request you to submit the following documents/information:

1. As per DSS analysis, the proposed area is **3.90 Km away from the Gir Wildlife Sanctuary**. Thus, the approval of CWLW shall be submitted for the area in Gir Wildlife Sanctuary and its eco-sensitive zone.
2. FRA certificate for CA land and diverted land as per Para 6(e)(ii) of CA rules-2003 shall be submitted and uploaded.
3. Certified copy of part-II shall be uploaded on the webportal.
4. The proposed area for diversion is Reserved Forest and CA on degraded forest land does not fit in any category given in Para 2.5(i). Thus, **CA on non-forest land shall be submitted**.
5. The **CA on equivalent non-forest land** along with revised site specific CA scheme shall be submitted as per the Para 2.8 (iii) of FCA Handbook 2019 and shall include the following points also:
 - a) Saplings to be planted (Minimum standard height and collar girth species wise).
 - b) Soil & Moisture conservation works.
 - c) Regeneration cleaning.
 - d) Silvicultural and other activities as prescribed in the working plan.
 - e) Species to be planted (species wise number of plants).
 - f) Details of proposed monitoring mechanism/outcome parameters.
 - g) Technical and administrative approvals from the competent authority.
 - h) The revised CA scheme shall be uploaded on e.portal.

Further, necessary action will be carried out after receipt of above information.
