No comments have been given by the State Govt on this. Since this instant proposal is to be forwarded to the Ministry for approval of the Competent Authority, in this regard the tentative timeline for payment of the 2% NPV, along with the comments of the State Govt may be submitted to this office to enable this office for inclusion of its details in the proposal while submission.

Further, the alternate CA land proposed and the KML file submitted has been examined under DSS software and found that the whole area is falling under Moderately Dense Forest. the State Govt is requested to have this proposed area for CA site be inspected by an officer not below the rank of Conservator of Forests with specific report on the density of the proposed CA site along GPS Coordinates and photographs.
