महोदय.

मुझे आपका ध्यान उपर्युक्त विषय से सम्बन्धित संदर्भाकिंत पत्र की ओर दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण) अधिनियम, 1980 की धारा- 2 के अनुसार गैर वानिकी उद्देश्य के लिए 1.47 वन भूमि की मांग की गई है।

- 2. प्रस्ताव से सम्बन्धित निम्नलिखित जानकारी भेजने का कष्ट करे:
  - i) Copy of document in support of the competence/authority of the person making this application to make application on behalf of the user agency under column A-3(xvii) to be uploaded correctly. Person making application under column A-3 is Sh. Shiv Anand, Executive Engineer, TLMSD-3 Udhampur whereas authorization in authorization letter uploaded under column A-3(xvii) is given to **Assistant** Executive Engineer, TLMSD-1 Udhampur.
  - ii) Layout plan/linear plan showing dimension wise area calculation of the project be uploaded online under additional information details in part I
  - iii) SOI topo-sheet of the project site be uploaded online in part I.
  - iv) DGPS map of the CA site be uploaded online in part II.
  - v) Number of trees, poles and plants to be felled to be confirmed. In column 4(ii) of part-II online no. of trees is shown as 429 whereas in "cost of Enumeration of trees/poles involved in the proposed site" it is shown as 29 trees/poles.
  - vi) Enumeration list of trees to be felled be provided.
  - vii) Undertaking from user agency to pay CA, NPV and Addl NPV to be uploaded.
  - viii) Approval of the project by competent authority to be provided.
  - ix) Number of poles to be erected in forest land and in non forest land to be provided.
  - x) Density mentioned in "Details of Vegetation available in the forest land proposed for diversion" under column 4 in part II to be corrected from 60 to 0.6.
  - xi) Approx distance of the proposed site for diversion from boundary of forest under column 7 of part-II has been given as 0.25 km. This needs justification.
  - xii) In the CA estimate there is no mention of prevailing daily minimum daily wages. No adjustment for yearly wage escalation in the 10 year period of CA plantation has been kept in estimate.
