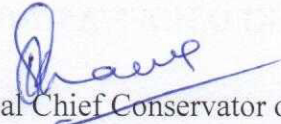
With reference to the above subject, this office vide Ref (1) submitted the additional information to Government of Karnataka for seeking 'in-principle' (Stage-I approval) under Section 2 of Forest (Conservation) Act, 1980 for above mentioned proposal. Accordingly, Government of Karnataka vide Ref (2) letter dated 01-08-2023 has submitted the same to Government of India.

In response, the Government of India vide Ref (3) has informed to furnish action taken report against user agency as per para 1.21 (i) (a) of the Comprehensive FC guidelines. Further, if no person executing the work is traceable, then the provisions of

section 3 (B) (1) (a) and (b) of F(C) Act will apply and the State Government may inform the action taken on such persons (copy enclosed).

Accordingly, Government of Karnataka vide Ref (2) letter dated 30-09-2023 has communicated the Government of India letter and sought information.

Therefore, you are directed to submit a detailed report on the information /documents sought by Government of India to this office at the earliest for further processing the proposal.
