विषय: Diversion of 8.0678 ha of forest land in favour of M/s Friends Him Energies, C/o Near Happy Sr. Sec. School, Jail Road, Gurdaspur- 143521 for the construction of Siul-iv-SHEP, within the jurisdiction of Churah Forest Division, Distt. Chamba, H.P.(Online Proposal No. FP/HP/HYD/35437/2018)

महोदय,

उपरोक्त सन्दर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरांत निम्नलिखित कमियां पाई गयी हैं:

1. All dumping sites are proposed in forest land having proposed tree felling of 12 trees while the availability of non forest land is not analysed for the purpose. Hence, the State Govt. may examine the availability of non forest land for muck dumping and the report in this regard may be submitted duly certified by the DFO to this office.
2. The Row for 33 KV T/L is taken 15.62 m instead of 15 m which need to be justified by the state govt.
3. The area calculation with the total length of T/L 5341.61 m comes out to be 8.35 ha while the details pertaining to T/L given with the proposal show this as 8.19 ha (6.9259 ha forest +1.2687 ha private) which needs to be re-assessed and revised. T/L detail in forest & non forest area may also be required to be furnished by the state govt.
4. In online Part-I Para B 2.3 nine villages are proposed to use for area under this project but the NOC and FRA proceeding given only for the village panchayat "Bhandali" This may required to be corrected accordingly.
5. The CWLW stated that the project is outside the boundry of Gamgul Siyabehi Wildlife Sanctuary but in the DSS analysis it touches the portion of Wildlife Sanctuary. Hence the State Govt. may submit the comments in this regard from CWLW.
6. State Govt. may mention the scientific name of trees in online Part II at para 4 (ii).
7. State Govt. may submit the FRA certificate with all annexures, Techno Economic Clearance and Implementation Agreement to this office.
8. The state govt. may clarify whether any river basin study has been done regarding carrying capacity to generate power from the said river? If yes, provide details in this regard to this office and if not yet done, the planning to do so in near future may be intimated.
9. In Para-16 of online Part-II, justification for locating the project in forest land has been furnished and uploaded instead of recommendation of DFO.

10. Under Cost Benefit Analysis, benefits of forest land diversion has been provided in old format instead of new format. Further, in the format meant for estimation of cost of forest diversion, all the parameters have not been quantified and expressed in monetary terms.
