
महोदया/Madam,

With reference to the subject and reference cited above, I am directed to request to submit the following additional documents / clarification etc. at the earliest for further consideration of the proposal under FCA, 1980;

- i. The existence and nature of RoW as per the RF notification in each of the stretch.
- ii. Report on violation does not clearly says whether the violation actually happened in the area/ alignment proposed for diversion or elsewhere. Further, the report on violation is not clear about the agency involved, nature of violation etc. Therefore, a detailed report indicating the nature/ type, extent of violation and the persons/agency responsible for the said violation and action taken by the forest department on the violators along with relevant documents.
- iii. Applicability of CA and NPV is to be intimated as per the prevailing norms.

It is further requested that details as sought above may be submitted at the earliest for further consideration.
