Eastern (NE) Block, Sandur North Range and Taluk, Ballari District
for Timmappangudi Iron Ore Mine ML No. 2605 in favour of M/s
Karnataka State Minerals Corporation Limited (Erstwhile Mysore
Minerals Limited)

Sir,

I am directed to refer to the State Government's letter No. FEE 49 FFM
2022 (e) dated 03/11/2022 on the subject cited above and to inform that
the above proposal was examined and in order to forward the proposal to
Ministry, it is requested to furnish following clarification/ information;

- 1.The complete compliance report on the conditions stipulated in
forest clearance approval letter dated 18th April, 2001 and 8th
November, 2004 for diversion of 78.50 ha and 98.224 ha of forest
land respectively.
2. It may be clarified whether the non forest land identified to an
extent of 10 ha in Sy. No.1251 of Kudthini Village is part of CA land
identified *in lieu* of earlier diversions or otherwise.
3. As per guideline issued by Ministry dated 27.05.2015, 02.08. 2017
and as per para 7.9 comprehensive guideline, the mining projects

for which diversion of forest land have been approved before 27/05/2015, the user agency is required to take approval under F(C)Act, 1980 in respect of the forest land falling in safety zone outside the mining lease area. The status of the compliance of the same may be intimated.

4. The State Government has recommended diversion of forest land for the approach road in favor of Karnataka State Mineral Corporation Limited. The Status of Change of name of user agency from erstwhile Mysore Minerals Limited to Karnataka State Mineral Corporation Limited may be intimated.
