महोदय,

उपरोक्त विषय पर सन्दर्भित पत्र का आशय ग्रहण करते हुए प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी है। अतः राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें, तािक अग्रिम कार्यवाही सुनिश्चित की जा सके:—

- 1. In para-A-1(vi) of Part-I, the shape of the forest land proposed to be diverted is mentioned as 'Linear' instead of 'Non-linear'. State Government may correct the same online.
- 2. In para-C of Part-I, KML file of proposed CA area has been found uploaded instead of the KML file of the forest land proposed to be diverted for the project. State Government may upload the KML file of the area proposed for diversion at para C (ii), Part I online.
- 3. In para-E of Part-I regarding employment likely to be generated, permanent/regular employment is mentioned as '0' and temporary employment (number of person days) is mentioned as 2000 which does not appear to be correct keeping in view the cost of the project which is mentioned as Rs. 11,84,276 lakhs in para-A-1(vii). State Government may submit the clarification in this regard and provide the correct information.
- 4. In para-G of Part-I, the cost benefit analysis has been uploaded in the old format. State Government may upload/submit the cost benefit analysis in the new format.
- 5. In para-K of Part-I, FRA certificate has been provided in the format meant for Linear Projects instead of FORM-II meant for projects other than linear projects. State Government may upload the FRA certificate meant for the projects other than linear projects.
- 6. In para-L(vi) of Part-I, map in Survey of India toposheet showing the project components has been found uploaded instead of map showing the civil land proposed

- for CA. Moreover, KML file of the proposed CA area and other relevant documents *viz.*, ownership proof, non-encumberance certificate, MoU agreement have not been found uploaded at para-L. State Government may do the needful in this regard.
- 7. Although, the CAT Plan has been uploaded at para-M of Part-I but the hard copy of the same has not been provided. State Government may submit the hard copy of the CAT plan.
- 8. In the documents showing length and width of the project uploaded at S.No. 30 of additional documents in Part-I, the total forest land involved is mentioned as 10.236 instead of 9.397 ha. State Government may submit the revised documents showing forest and non-forest area.
- 9. In para-4(ii), 4(iii) & 4(iv) of Part-II, the number of trees at FRL, FRL-2 mtr and FRL-4 mtr is mentioned as 16 trees, 216 trees and nil trees respectively which is not correct. State Government may submit clarification and provide correct information in this regard.
- 10. In para-13 of Part-II, the details of the proposed CA area has not been filled up in the table and the KML file, geo-referenced map and the map in SoI toposheet have also not been uploaded. State Government may fill the all the detail at para 13 and upload maps and KML file at para 13 Part II online.
- 11. The area of land required for 3 no of muck disposal sites mentioned in component-wise breakup at para-B-2.4 of Part-I does not match with the area and dimensions of the 3 no. of muck disposal sites given in the Muck Disposal Plan provided with the hard copy of the proposal. State Government may remove this discrepancy and submit the actual detail of the same.
- 12. State Government as well as the User Agency has not mentioned anything about the Environmental Flow (E-Flow) required to sustain forest water ecosystem etc. downstream of diversion weir upto TRT. State Government may do the needful in this regard.
- 13. It is seen from DSS analysis of the area proposed for CA that 2.00 ha area of Patch-1 (7.984 ha) falls in MDF. Similarly 3.00 ha area of Patch-4 (4.872 ha) also falls in MDF. State Government may submit the plantation scheme inlieu of area falling in MDF/VDF.
- 14. Copy of TEC and Implementation Agreement has not been submitted with the proposal. State Government may submit the hard copy of TEC and Implementation Agreement.
- 15. Administrative approval, geologist report and aerial distance certificate not found uploaded.

The State Govt. may remove above shortcomings and submit revised documents/information/clarification and upload the documents/information wherever required. यदि चाही गई सूचना पत्र जारी होने की तिथि के 60 दिनों के भीतर (अधिकतम 90 दिन) इस कार्यालय में प्राप्त नहीं हुयी तो प्रस्ताव को निरस्त किया जा सकता है।
