With subject and reference cited above, I am directed to inform that the shape files of proposed C.A. area submitted by State Govt. vide letter under reference-2 has been examined in the Decision Support System (DSS) of Forest Survey of India and it is observed that out of 24 ha C.A. area, 10 ha area contains MDF and balance 14 ha is open forest.

It is therefore requested to kindly identify alternate patch of non-forest land for compensatory afforestation and submit the same along with shape file to this office for further necessary action.
