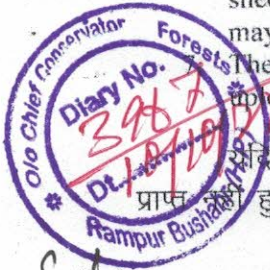
महोदय,

उपरोक्त संदर्भित पत्र द्वारा प्रस्तुत प्रतिउत्तर का ध्यानापूर्वक अवलोकन करने के पश्चात प्रस्ताव में अभी भी निम्नलिखित कमियां पाई गई हैं:-

1. In Layout Plan/Site Plan, only entry road is marked. However, in KML file proposed road is extended beyond bus stand area. Therefore, same may be reviewed and correct KML file/Layout Plan identical to each other may be submitted.
2. In reply to observation no. 4, revised KML has been submitted. However, neither alternates explored nor beneficiary villages are marked in KML file. Therefore, same may be marked in the KML file.
3. In online Part-II, Para 4(ii), 37 saplings and 3 trees are mentioned, however in abstract of trees, 16 trees and 40 saplings are mentioned. This variation in vegetation present in the area may be reviewed and correction in respective document/Part-II, Para 4(ii) may be carried out.
4. As per revenue record (Tatima), a transformer of Himachal Pradesh State Electricity Board Ltd. (HPSEB Ltd.) is established in the diversion area. Therefore, NOC from HPSEB Ltd. may be provided.
5. Since the proposed diversion area is adjacent to existing Highway/HPPWD road. Therefore, NOC from HPPWD/NHAI may be provided.
6. In Part-II, Para-4, density of vegetation is mentioned as 0.4 (Dense Forest), however NPV has been calculated with open forest category. Therefore, same may be reviewed and revised NPV calculation sheet/bill with Dense Forest category and revised NPV rates as per Ministry's Order dated 07.01.2022 may be submitted.

The length and width document uploaded in portal is not in downloadable form. Therefore, same may be uploaded in downloadable form.

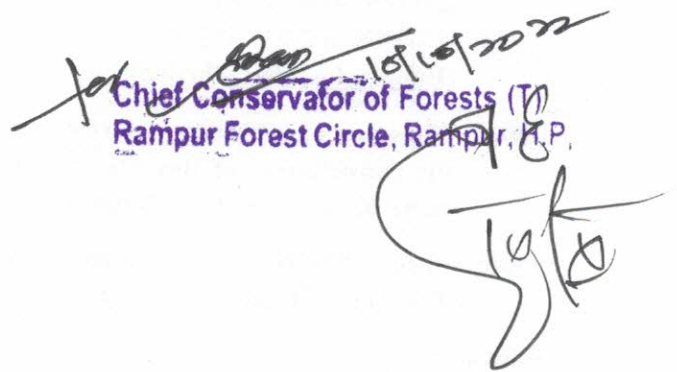
