It is to inform that, on verification of Section 2 proposals for “diversion of forest land for grant of Quarry Lease for extraction of Quartz & Feldspar over an extent of 4.41 Ha in Sy.No.553 (part) of Chaganam RF & Village Sydapuram Mandal, Nellore Division of SPSR Nellore in favour of M/s. Chettinadu Morimura Semiconductor Material Pvt., Limited” the Chief Conservator of Forests, Guntur vide reference cited has called for the following additional information.

1. The reclamation plan is not included in the mining plan. Hence, it is requested to get the reclamation plan included in mining plan by the Mines & Geology Department and furnish the same to this office.
2. The Asst. Director of Mines & Geology, Nellore in his Ir No. 4264/Q/16, dt. 11-5-2017 stated that, in the proposed area for mining lease, small pits area noticed. In this regard, detailed justification of the Mines and Geology Department is required prior to inspection of the area by the under signed.
3. In point No. 2, the Asst. Director, Mines & Geology, Nellore stated that, and extent 5 Ha. of the CA area has been identified by the District Forest Officer, SPSR Nellore, which is to be rectified. The Non-forest CA area has been identified over an extent of 4.65 H. n Sy.No. 723/1 of Bollupalli village, Ardhavedu Mandal, Turimerla Range of


Giddalur Division. In this regard, the report of the Asst. Director, Mines & Geology, Nellore has got to be revised.

4. As per authenticated DGPS map and mining plan furnished by Dy. Director of Mines & Geology, Nellore for diversion of 4.41 Ha. of forest land for the said purpose, the compartment No. 125 of Chaganam RF, Venkatagiri Range of Nellore division was mentioned. Whereas in the proposals the compartment No 122 is mentioned. The same has be revised in mining plan as per actual compartment Number.

It is requested to please get all the above details rectified as mentioned against each point and send the above information along with the information from Mines & Geology Department at an early date.
