With reference to the above-mentioned subject and letter under reference, I am directed to request you to submit following documents/information:

1. The component / purpose wise break-up of mining shall be submitted.
2. Details of Reclamation plan shall be submitted.
3. FRA certificate for mining project/ block project and NOC of Gram Panchayat & proceedings of Gram Sabha shall be submitted.
4. Copy of prospecting approval shall be submitted.
5. Status of CRZ shall be submitted.
6. As per DSS analysis, one transmission line is passing through proposed CA area. Thus, kindly submit either revised CA land or exclude area of transmission line and details of revised area along with KML file, CA scheme and maps.
7. NOC from road authority for shifting/breaking of road shall be submitted.
8. Details of forest area involved in complete lignite mining area along with the copies of Stage-I & Stage-II obtained under F(C)A, 1980 and copy of Environment clearance shall be submitted.

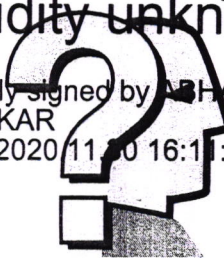
