Kindly refer to your Proposal No. FP/HP/Others/37317/2018 dated 21st December, 2018 submitted online on Parivesh portal for want of approval of the Ministry of Environment, Forest and Climate Change, Govt. of India under Forest (Conservation) Act, 1980 for the diversion of 0.2407 hectare of Forest land for the construction of Training Centre, Prisons & Correctional Services at Shimla.

2. On careful consideration of the Proposal submitted on Parivesh portal as mentioned above, following deficiencies have still been pointed out by this office which in-fact is required to be attended on priority, please:-

1. Place and Date has not been mentioned in most of the documents attached in the proposal folder submitted to this office as well as uploaded online on Parivesh portal. Therefore, the same may be reviewed and rectified accordingly, please.
2. The Detailed Note on the project has been found attached with the proposal folder but is not as per the consonance of the Check List of the Forest (Conservation) Act, 1980 i.e. the same has not included the information regarding the number of villages and number of persons to be benefited from the project including employment generation. Therefore, the same may be reviewed and rectified accordingly and ensure to upload the same online in the Part-I under additional information details on Parivesh portal, please.
3. Check list No. 8 has been found attached with the proposal folder submitted to this office but same has not been uploaded online on Parivesh portal. Therefore, the same may be ensured to upload in the Part-I under additional information details, please.
4. As per the details provided under Column B-4, the Component wise breakup needs to be marked in the KML file and uploaded online on Parivesh portal, please.
5. Vide your letter No. 4-19/81-Jails-5844 dated 12th October, 2023, you have intimated that the revised enumeration list pertains to DFO office which does not serve the purpose. Therefore, in this respect the User Agency same may be collected from the concerned Range Forest Officer i.e. Range Forest Officer, Mashobra and may be uploaded online, please.

Therefore, the proposal folder as received in this office is returned herewith for taking appropriate necessary action into the matter and attending the above shortcomings within 15 days, please.
