महोदय,

उपरोक्त विषयांकित में संदर्भित पत्र का आशय ग्रहण करते हुए सूचित करना है कि राज्य सरकार द्वारा बिन्दु संख्या 1 एवं 2 के सम्बन्ध में प्रस्तुत किये गए प्रतिउत्तर त्रुटिपूर्ण हैं। अतः राज्य सरकार उक्त बिन्दुओं पर चाही गई सूचनाएं संपूर्ण रूप से प्रेषित करने का कष्ट करें, ताकि प्रस्ताव पर आगामी कार्यवाही सुनिश्चित की जा सके :-

1. Regarding the observation point no. 1, State Govt. has submitted that the MMP (Muck Management Plan) and the Reclamation Plan has been authenticated by DFO Dalhousie and attached herewith. However, No documents regarding MMP and Reclamation Plan has been authenticated by concerned DFO nor uploaded on designated column Part-I of PARIVESH Portal. Therefore, State Govt. may provide/upload the MMP duly authenticated by concerned DFO and may also provide/upload the Reclamation Plan for 2 numbers dumping sites proposed on forest land.
2. Regarding the observation point no. 2, State Govt. has submitted that the undertaking of the user agency to pay the cost of the SMCP (Soil and Moisture Conservation Plan). However, SMCP has not been submitted/uploaded in this regard. Therefore, State Govt. may review and revise the proposal accordingly as per the recent directions of MoEF & CC vide letter dated 7.6.2022 and may submit the Soil and Moisture Conservation Plan along-with detail cost of its implementation in to account of CAMPA is required to be deposited along-with Stage-I approval. However, in cases where it is not possible for the State Govt. to submit the compliance due to delay in preparation of such plan, a lump sum

amount of 0.5% of the project cost shall be realized from the User Agency and submitted along-with the Stage-I compliance. The deficit amount, as per the said plan, if any, from the money already realized to the tune of 0.5% of the project cost shall be deposited in CAMPA account prior to actual working on the forest area. An undertaking to this effect may also be submitted.

State Govt. shall ensure that all the desired information/documents are uploaded in designated column on Part-I/II of PARIVESH Portal.
