Sub: Proposal for diversion of 32.693 ha of Deemed forest land in respect to plant premises of Hill Cement Company Limited at Mynkre in East Jaintia Hills District for Captive Cement Plant-reg.

Sir,

Please refer to the proposal submitted by Government of Meghalaya vide No.FOR.22/2022/102 dated 31.10.2023 on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal forwarded by the State Govt has been examined in this office in the light of Forest (Conservation) Act, 1980, and Rules/Guidelines framed thereunder. The State Govt. is requested to provide following additional information for further processing of the case: -

- 1) As per JIT-I report out of 68.313 ha the forest land is 50% or more. The State Govt may clarify why only 32.693 ha proposed for seeking diversion.
- 2) Detail purpose-wise breakup of total land required for diversion including those for ancillary structures.
- 3) This proposal involves violation of FC Act, 1980. Any action has been taken under section 3A and / or 3B of FC Act and report with full details of violation may be submitted by State Government.
- 4) The KML shape file examined under DSS software and found that the computed shapefile is 32.603 ha instead of 32.693 ha. Corrected Shape file may be submitted.
- 5) Distance from the nearest Protected Area.
- 6) Undertaking from the user agency towards the cost for tree felling.
