
(2). Further the letter was communicated to Range Forest Office Mandagadde, Thirthahalli and Agumbe in reference (3) for field inspection of area which is proposed for diversion.

In reference (4), (5) and (6) Range Forest office Mandagadde, Thirthahalli and Agumbe have submitted the report to this office. As per the reports as stated above, it is requested to provide details for the below mentioned observations for further processing of the proposal,

1. Few Geo referenced and topo maps of villages as mentioned in the proposal is not submitted in hard copies for physical verification of the project on ground.
2. As per reports of Range Forest office Mandagadde, Thirthahalli and Agumbe in reference (4), (5) and (6) the proposal is incomplete as the project is carried out in more villages and total forest area utilized is incomplete in the present proposal.
3. The total forest area requested for diversion as per proposal is not matching with the forest area as per project carried out on field.

It is here by requested to provide above mentioned details at the earliest for further processing of this proposal.
