Please refer to Pr CCF (HoFF) office order No 1/2022 dated 02 May 2022 vide which Divisional Forest Officer (Publicity), Mist Chamber, Khalini, Shimla and Divisional Forest Officer (HQ) of circles are designated as state level Nodal Officer and District level Nodal Officer respectively for the scheme " The Plantation- Ek Buti Beti ke Naam" notified by the Government of Himachal Pradesh vide Notification No FFE-B-F(5) 1/2019 dated 20<sup>th</sup> September, 2019 (Copy of the same can be downloaded from the H.P. Forest department web site ([https://hpforest.nic.in/files/Ek buti beti ke naam.pdf](https://hpforest.nic.in/files/Ek%20buti%20beti%20ke%20naam.pdf))

The Goals, Major Components, Salient features, Implementation Mechanism of the scheme are given in the above-mentioned notification and is being implemented throughout the state for last two and half years. The main features of the scheme is to gift five saplings to the family of a newly born girl child in the state along with a kit containing instructions for plantation & maintenance, a plant guard (as per requirement), a package of vermicompost and name plate with new born's name pointed on it.

In the above notification implementation mechanism is also given by which identification of the new born girl child is to be done by the representatives of the Forest department on monthly basis and the list be compiled at Forest Range Office level. After that robust and healthy plants (saplings) of identified species are to be gifted to the parents of the newly born child during planting season and the plantation are to carried out once or twice in a year i.e. during Mansoon or winter season as per the suitability of the locality.

In the scheme it is mentioned that record keeping is to be done by the concerned Forest Guards about the girl child, parents, location of plantation (geo coordinates), species planted and status of their survival during subsequent years. As per scheme the saplings are to be distributed during each of the first five years and saplings for the replacement of died plants are to be provided in the subsequent years upto maximum of two years.

Since the data base of the above record is to be maintained at Headquarters of HPFD, it requested to supply the data of your circle electronically (excel sheet) in the following formats (Format I is to be filled for three years, i.e 2019-20, 2020-21 and 2021-22 and Format II/ Format III for two years 2020-21, 2021-22):
