With reference to the above mentioned subject and the proposals under reference, it is to inform you that after cross-examination of the forest diversion proposals it is found that the uploaded KML files and maps for the proposed combined CA land measures an area of 6.97 hectare which equals to 52.28 Bighas whereas the jabanbandi copy and the encumbrance certificate pertaining to the revenue land for raising of Compensatory Afforestation mentions an area of 50 Bighas only. Since, the proposals are now pending at your level, therefore, you are requested to raise an EDS to the user agency to rectify the CA land in the relevant documents and maps through MoEF & CC web portal.
