

Sir,

With reference to the above, I am directed to inform that on scrutiny of the aforesaid proposal the following observations have been made.

1. In the Site Inspection Report of the DFO, Jharsuguda Forest Division and in Part-II of the proposal it has been reported that during the year 2003-04 mixed plantations have been raised under Compensatory Afforestation Scheme over Plot No.1690, 1379, Khata No.754 (21.38 ha) of village Balijore by Sambalpur North Forest Division (Now Jharsuguda Forest Division) in lieu of diversion of 16.198 ha of forest land for construction of 2nd 220KV/DC line from Ib-Thermal to Budhipadar by OPTCL. Further, during the year 2004-05 mixed plantations have been raised under Compensatory Afforestation Scheme over Plot No.1380, Khata No.754 (7.26 ha) of village Balijori by Sambalpur North Forest Division (Now Jharsuguda Forest Division) in lieu of diversion of 40.79 ha of forest land for construction of 220 KV DC Line from Budhipadar to Bolangir via Burla by OPTCL.

It may be clarified if Compensatory Afforestation on the revenue forest land

have been taken up as per the condition imposed by the MoEF pertaining to the aforesaid proposals of OPTCL. If so, the copies of the relevant orders may be furnished along with the status of mutation of CA land in favour of this Department and subsequent declaration of revenue land as Protected Forests.

2. In the Site Inspection Report of the DFO, Jharsuguda Forest Division and Part-II of the proposal the density of vegetation of the proposed area have been reported as 0.60% of Eco-Class-II (Dense Forest). This may be examined with the extant guidelines of the MoEF&CC.

The compliance report on the above observation may be submitted at the earliest.
