Sub: Proposal for diversion of 0.99524 hectare of forest land for construction of approach road leading to the site of resettlement of Bru-migrant of mouja-Anandapur and Kalamchoura in favour of SDM, Sonamura under Sepahijala District.

Sir,

Please refer to the State Government's letter in the reference on the subject cited above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. State Govt is requested to kindly furnish the following information for further processing of this proposal:

- The aerial distance of the proposed area from the nearest Protect Area/Wildlife Sanctuary/National Park.
- The original or colour scanned SoI map indicating the proposed area, muck dumping sites and compensatory afforestation sites as the submitted map is not legible.
- The technically approved and duly signed scheme for avenue plantation on the road side.
- The proposed width of Right of Way and length of the proposed road.
- The muck dumping plan and muck dumping sites along with the GPS coordinates.
- The 3 alternatives route examined is to be plotted on SoI toposheet providing the reason and justification for choosing the present proposed route.
- The GPS coordinates of the starting and end points of the proposed road.
- The current status of mutation of the non forest land proposed for compensatory afforestation land.
- The undertaking certificate by user agency for addl. NPV payment.
- State Govt to furnish further justification on the effort that was put into finding revenue land by the State Govt establishing the inevitability of involving forest land for this proposal.
- Steps to be taken by State Govt. to upset imminent pressure on surrounding forests immediately after rehabilitation and in the future has not been concrete and spelled out well by the State Govt.
