2. The subject cited proposal received vide communication under reference, has been scrutinized and found some shortcomings as under:

1. Against column No.7 of part-II the legal status of forest has been filled up "Protected and Unclassified forest". The same may be checked and correct category of the forest be filled up.

2. The area proposed for muck excavation during the time of constrction of project area 10.3 ha has been proposed for muck dumping and detail given at page-57 but component wise muck plan has not been prepared. Whether all the muck extracted is to be carried out to the proposed duming sites or otherwise. Please attach the component wise muck dumping plan.

3. At page-132 the statement showing details of non forest area involved in the proposal has to be filled up on the prescribed format as per the Check list No.7

issued by the Gol.

4. The density of the vegetation has been calculated wrong and value of open forest has been applied. Accordingly the value of NPV may aslo be checked and corrected.

5. The enumeration list of trees placed at pages- 155-229 contains trees of Forest, Govt. & Private land but list of trees coming in the private land be prepared separately.

6. Check list No. 16 placed at pages- 234 reflects non forest land for Compensatory

Afforestation. Please make it clear category wise.

7. Joint certificate of non availability of non forest land for raising compensatory afforestation has been placed but the certificate pertaining to the Competent Authority has not been given. This may be placed in the folders.

The statement showing details of project component, division wise given at page-453 in which private land proposed for construction of project has been mentioned 1.3375 ha whereas in part-I at page-8 i.e. 1.2135 which is contradictory. Actual figure may be indicated in both of the sides.

9. In Check list No.32 the reclamation plan for muck dumping has been placed at pages 515-16 in which necessary certificate may be obtained from the user agency

that the said area will be developed and return back to the Forest Department.

You are therefore, directed to submit the proposal to this office properly after scrutinizing and correctly the NPV etc. in hard shape as well as online. Submission of incomplete case invites unnecessary correspondence and delay which should be avoided in future. The proposal floders as received vide communication under reference are returned herewith in original for doing the needful.

3. The abstract of the trees has been placed at page-155-164 in which total 53675 trees and area 236.24 ha proposed for diversion but the density calculation is

wrong. Please recheck and do the corrections.

Copy is forwarded to General Manager, TM&TP, HEPs, HPPCL, Kotli, Distt. Mandi HP for information and necessary action. In part-I the main application form certain documents have been recorded but page numbers have not been mentioned and the component wise detail has been given in which forest land required 406.79 and private land required for 1.213 ha, but as per the detail note private land for the construction of the project has been shown 38,37 ha. The same may be seen and corrected.
