**Subject:- Diversion of 397.8863 ha of forest land for the construction of Sunni Dam HEP on Satluj River in favour of SJVN Ltd. within the jurisdiction of Shimla, Kotgarh and Karsog Forest Divisions in district Shimla & Mandi.**

**Memo:-**

Kindly refer to your office letter No.C-28-b-1600/FCA(Online) /Shimla/6657 dated 2.12.2020 on the subject cited above.

2. The proposal received has been found incomplete. The following shortcomings have been noticed in the proposal which are to be completed. All the requisite documents may please be placed in the proposal folder with proper numbering and index.

**Karsog Forest Division:**

- 1.** Density of vegetation against column No.4 (i), 8.97 has been mentioned in online part-II as well as in hard copy of part-II. The density of vegetation is required to be mentioned in decimal unit.
- 2.** The scientific names of other species mentioned in online part-II, against column No.4(ii) are required to be mentioned, where only local names have been mentioned.
- 3.** CA schemes for 404.3842 ha of forest land have although been uploaded on the portal against column No.13(ii), but all the CA schemes with 10 years of maintenance have not been proposed on revised cost norms. CA schemes are required to be prepared on revised cost norms conveyed vide letter No.Ft.State CAMPA/20210/Norms/Vol.II dated 23.5.2020. Further, ~~of~~ CA scheme of 40 ha uploaded /placed is only with 5 years of maintenance.

**Kotgarh Forest Division:**

- 1.** Against column No.3 of online part-II, District wise area to be diverted in the division, has not been mentioned and Nil has been mentioned against this column, The forest area proposed for diversion in the division is required to be mentioned against this column.
- 2.** The scientific names of other species mentioned in online part-II, against column No.4(ii) are required to be mentioned, where only local names have been mentioned.
- 3.** Working plan prescription has not been mentioned against column No.5 in online part-II.

4. CA schemes are required to be prepared on revised cost norms conveyed vide letter No. Ft.State CAMPA/2020/Norms/Vol.II dated 23.5.2020. Revised CA scheme is required to be uploaded in online part-II and submitted to this office for placing the same in the proposal folder.
5. Against column No.13(iii), although digital maps of CA sites have been uploaded but have not been scanned properly <sup>as</sup> all the maps have not been signed by the DFO concerned.
6. Against column No.13(iv), although maps of CA sites on toposheet have been uploaded but have not been scanned properly as in all the maps, the CA sites are not visible and also have not been signed by the DFO concerned.
7. District profile mentioned in respect of Kotgarh Forest Division is not in order in hard copy of part-II as well as in online part-II.

**Shimla Forest Division:**

1. Bill of NPV is also required to be uploaded against additional information detail in online part-II. Further, the calculation of NPV has also not been found placed in the proposal folder.
2. The recommendations of CCF are not in order. Now this can not be uploaded at this level and is to be get uploaded from nic cell of MoEF & CC. Necessary mail is being sent to nic cell of MoEF & CC.
