Sub: Proposal for diversion of 25.00 hectare of forest land for settlement of BRU migrant of Mouja-CCRF in favour of SDM Kanchanpur under North District.

Sir,

Please refer to the State Government's letter in the reference on the subject cited above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. State Govt is requested to kindly furnish the following information for further processing of this proposal:

- (i) The lay out map indicating detailed all the purpose wise break up of the proposed area in hectares.
- (ii) The GPS coordinates of the proposed area and CA area.
- (iii) The scientific names/local names of trees mentioned in "Others" category in the submitted enumeration list.
- (iv) The alternatives examined and the reason and justification for choosing the present proposed area along with relevant maps.
- (v) To provide the specific component of conservation for the proposed Rs. 20.00 lakhs for ex-situ conservation.
- (vi) As per para 2.(iii) the land for C.A. should be degraded land. State Govt. may justify why degraded land is not proposed but ANR was proposed instead on MDF type of forests.

- (vii) The justification for recommendation for SMC works, patrolling vehicle and fencing amount to Rs. 62 lakhs by the State Govt.
- (viii) State Govt to furnish further justification on the effort that was put into finding revenue land by the State Govt establishing the inevitability of involving forest land for this proposal.
- (ix) Steps to be taken by State Govt. to upset imminent pressure on surrounding forests immediately after rehabilitation and in the future has not been concrete and spelled out well by the State Govt.
