- As the project site is also passing through Eco-sensitive zone of Asola Bhatti
  Wildlife Sanctuary in Tughlakabad region. Hence, it is essential to take the
  necessary permission from National Board of Wildlife and submit the same to
  undersign.

It is requested that all the above mentioned documents must be certified by competent authority and upload all these documents in part 1 from your side and also submit 3 sets of these documents in Hard copies with CDs of .kml files of Land for Diversion (Project Site) and CA land must submitted in the office of undersigned.
