
Sir,

With reference to the above mentioned subject and letter under reference, it was observed that in the forwarding letter of State Govt dt. 07/09/2019 at point no. 6 submitted that project is 0.00 km from **Gir Sanctuary and Gir National Park**, in SIR of DFO, Junagadh at point no. 3 & 10 stated that proposal is part of **Girnar Wildlife Sanctuary** and Part-II at (vi) legal status forest is **Girnar Wildlife Sanctuary**.

In this connection, I am directed to request you to submit the following documents / information / clarification:

1. The above stated variation in the location of project may be clarified. Legal Status of Forest land, location in side the Protected area & accordingly, clearance from the CWLW, Govt of Gujarat shall be submitted.
2. FRA certificate for diverted land and CA land as per Para 6(e)(ii) of CA rules-2003 shall be submitted and uploaded on the webportal.
3. The CA scheme along with Sol toposheet map shall be uploaded on e.portal.
