Sub: Proposal for diversion of 0.9955 ha of forest land for construction of 2 lane highway from Adampool to Ranka Sichey road in East Sikkim by Roads & Bridges Department, Govt. of Sikkim.

Sir.

Please refer to the State Government's letter No. 1758/FCA/FEWMD/566 dt. 27.08.2018 on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal forwarded by the State Govt has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The State Govt. is requested to provide following additional information for further processing of the case: -

- (1) The KML / Shape file (Hard & Soft copy) with polygon features of proposed area for diversion & Compensatory Afforestation area.
- (2) The SoI toposheet map submitted does not show the starting and end point for proposed road construction. Therefore, the State Govt. is required to re-submit the scanned SoI map with proper index, scale, caption depicting proposed area/alignment along with the GPS Co-ordinates at the starting point and end point of the prposed road.
- (3) The detailed break-up of land requirement i.e length & width for the proposed construction of 2 lane highway may be furnished.
- (4) The confirmation / certificate from the user agency that no muck will be disposed outside the diverted forest area.
- (5) In Part II Sl. No. 12 (e) the progress of compensatiory afforestation is shown as 746.42 ha against 1565.77 ha as on 31/3/13 i.e. 47.7 % only. The State Govt may clarify the low achievement of compensatiory afforestation.
- (6) Aerial distance from the nearest Protected Area, Wildlife Sanctuary and National Park may also be informed.
