
उपरोक्त विषयक एवं संदर्भित पत्रों के संदर्भ में अधोहस्ताक्षरी को यह सूचित करने का निर्देश हुआ है कि प्रस्ताव से संबंधित अन्य वांछित जानकारियाँ/स्पष्टीकरण की आवश्यकता है। अतः निम्नलिखित जानकारियाँ/ दस्तावेज प्रेषित करने का कष्ट करें :-

1. The area proposed for diversion is 244.039 ha while in online the area mentioned as 248.329 ha which should need to be corrected. The area correction is done by the undersigned in online Part I but accordingly corrections in other columns like component wise break up, village wise break up etc. and subsequently in Part II are needed to be done by the PP and DFO shall be uploaded.
2. The area in DSS analysis of the KML submitted for diversion area is found 249.82 ha while it should be 244.039 ha. Further the location of proposed station is also not marked on KML shall be uploaded.
3. The details regarding violation in Para 11 is not correctly filled regarding person responsible for violation. This need to be reviewed by the State Govt.
4. In Para 12 of online Part II of Alirajpur Division the information related to work progress seems incorrect. This need to be reviewed and corrected.
5. The component wise breakup need to be in more details because component like station building, Staff room, circulation area, internal roads etc are also involved as per the layout submitted in online portal as an additional document.
6. The format used for providing cost analysis in C/B analysis is not as per the format prescribed in the guideline. This need to be provided as per the prescribed guideline.
7. The DSS analysis of the CA area shows that for the proposed 494 ha area the calculated area comes 545.33 ha out of which 29 ha is MDF. The State shall be uploaded to correct the KML accordingly because the proposal required actual CA area of 488.078 ha only.
8. Further, in CA area of 45 ha marked in Sardarpur Range-469 overlapped with the area proposed for CA in some other case of FP/MP/TRANS/156656/2022 (6.145 ha) need to be reviewed and corrected.

9. It is also observed that the same KML file has been uploaded against 25.0 ha patch and 30.00 ha patch in Sardarpur Range-476. This also need to be reviewed and corrected.
10. The information provided against point 3 of this office EDS is not satisfactory. The detail regarding type of violation is to be mentioned with the action taken etc. This is informed that so cause notice has been issued to the concerned which is not satisfactory.
