Sub: Proposal for diversion of 0.05016 ha of forest land under the Laitkor Protected Forest at Lumparing for setting up Children's Park.

Sir,

With reference to the subject and reference cited above, I am directed to inform that the proposal submitted has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder and the following are the required additional information:

- (i) To explore an alternate non forest area as the proposal is not a site specific, if not available, reason and justification for selecting this site.
- (ii) The PCCF, Govt of Meghalaya has upheld the observation of the Conservator of Forest that the area has been broken up prior to obtaining forest clearance, however recommended as the land is required for public utility. In this regard, State Govt is requested to provide the reason why the proposed area can't be restored to forest status by exploring an alternate site for this instant proposal. In case, the replies to the point (i) and (ii) above are justified with proper reasons, then following information is required:-
- (iii) The detail break-up dimensions of the proposal.

- (iv) The minutes of the meeting held on 04<sup>th</sup> May, 2015 with village Durbar/ Gram Sabha of Upper Lumparing is to be signed by Headman, and original copy of the same be furnished to this office.
- (v) State Govt to upload this instant proposal completely on Ministry's website as it is showing pending with the State Govt.

State Govt is requested to kindly furnish the above requisite information to this office.
