Subject: Diversion of 0.2 ha forest land in favour Kokernag Development Authority for Construction of Tourist Facilitation Center and Security Cabin at Daksum, under forest division and District Anantnag, Jammu & Kashmir.

Sir,

I am directed to refer online proposal No. FP/JK/others/44473/2020 regarding the subject cited above and to request to submit/upload the following information on Parivesh portal in the instant proposal, so that the same may be forward to Integrated Regional Office Chandigarh for further necessary action:-

- i) Legal status of forest land proposed for diversion under column 2 of part II is shown as "Forest by dictionary meaning". This needs justification.
- ii) Layout plan/linear plan showing dimension wise area calculation of the project be uploaded online under additional information details in part I.
- iii) Undertaking from user agency to pay CA, NPV and Addl NPV be uploaded.
- iv) Correct certificate of competent authority to apply for the proposal to be submitted
- v) Proper site specific CA estimates mentioning prevailing minimum daily wages along with scope for adjusting escalation of wages in 10 years of the plantation be submitted
- vi) Density mentioned in "Details of Vegetation available in the forest land proposed for diversion" under column 4 in part II to be corrected from 0.6 to 0.2.
- vii) Revised Site suitability certificate of CA mentioning proposed CA site.
- viii) Approx distance of the proposed site for diversion from boundary of forest under column 7 of part-II has been given as 0.5 km. This needs justification.
- ix) Revised/correct KML file, DGPS map and SOI topo-sheet of the project site be uploaded under column 13 (ii), (iii) & (iv) of part I online.
