With reference to the cited subject and reference, it is to inform that following shortcomings have been observed in the diversion proposal after scrutiny:

1. The User Agency has not uploaded a correct kml file of the forest area proposed for diversion on PARIVESH portal;
2. The User Agency under PART I of the application has not uploaded the details of non-forest land identified for CA purpose. Further, The DFO has not uploaded details like CA scheme, CA map, suitability certificate etc under PART II of the application.

Further, I am directed to inform that, as per the **sub rule (16) (8) (ii) of Van (Sanrakshan Evam Samvardhan) Rules 2023**, the instant proposal shall be processed as per the provisions contained in the Van (Sanrakshan Evam Samvardhan) Rules 2023.

In view of the above, the instant proposal is returned to the State Government with a request to process the proposal as per the provisions contained in the Van (Sanrakshan Evam Samvardhan) Rules 2023 and resubmit the same to this office for further consideration.
