Subject: Proposal for diversion of 100.05 ha of forest land in favour of NPCIL for Mahi Banswara, Rajasthan Atomic Power Project (MBRAPP) -1 to 4. (online proposal No. FP/RJ/Others/22621/2016).

Madam/Sir,

I am directed to refer to the Government of Rajasthan's Letter No. P.1 (28) VAN/2022 dated 22.11.2022 forwarding their response on Ministry's letter of even no. dated 10.06.2022. After examining the response of State Govt. along with revised KML file uploaded on PARIVESH for instant proposal, the following shortcomings have been observed:

- i. As per the DSS analysis through satellite imagery, it is observed that a part of forest land located under 'SARWAN DERI B Forest Block' has not been included in the instant diversion proposal. The map is given in **Annexure** for ready reference. The same is required to be examined and necessary action is required to be taken accordingly.
- ii. The calculated degraded forest land for CA as per uploaded KML file is found to be 304 ha. instead of 286.10 ha. Thus, this variation needs to be re-checked and corrected KML file be uploaded on PARIVESH. The State shall also ensure that the area proposed for CA was not a part of the CA plantations of any other project.
- iii. The State was asked to submit the details of alternative sites which have been explored/examined for the execution of the project. However, the same have not been provided. The State has also not given any justification for locating the project in the proposed forest area.
- iv. The presence of settlements & Agriculture land on the area proposed for diversion was observed in DSS analysis. The State has not given any justification for the same.
- v. The copy of the approved R&R plan has not been submitted, which is required to be done.

In view of above, the State Govt. is requested to provide the information/document/clarification on the above points for further consideration of the proposal.
