With reference to above subject, this office vide Ref (1) has directed to obtain the Compensatory Afforestation on degraded forest land twice in the extent of forest land, KML, maps, CA scheme and other relevant documents.

In response your letter vide Ref (2) has stated that the User Agency has submitted the undertaking to assure the bear the cost of Net Present Value, Compensatory Afforestation and other charges. But the Compensatory Afforestation details are not submitted. Since it is protected area and Wildlife division, there is no provision for raising plantation in the management plan.
