Sir,

In inviting a reference to the subject cited above, I am to inform you that the Regional Empowered Committee (REC) in its meeting held on 29.10.2021 had discussed this instant proposal. The committee recommended the proposal subject to submission of the following:

- 1) Corrected KML / Shape file for the proposed diversion showing clearly the area for Mining, approach road and Safety Zone separately.
- 2) Corrected KML / Shape file for the proposed CA area over 11.419 ha.
- 3) State Govt to submit the exact distance of the proposed diversion site from ESZ.
- 4) Undertaking from the User Agency for the safety of labourers.
- 5) Undertaking from the User Agency that there will be no Pollution of Air, Water, Noise etc. due to the quarrying of sandstone / road metal, Murum and Shaly Earth.

The State Govt is requested to submit the information as desired by the REC at the earliest so as to enable this office to take further necessary action.
