

With reference to above subject, the online proposal (PART-I, II & III) received by this office on 27-06-2022 vide Ref (1) to (3) above and the hard copies of the proposal have been examined and found to be incomplete in the following aspect.

The Deputy Conservator of Forests Belagavi Division, vide Ref (1) Site Inspection letter dated 02-03-2022 stated that the User Agency/Contractor has violated Forest (Conservation) Act, 1980 with Excavation of trenches for laying pipeline illegally in 2020. Hence, the concerned beat guard has booked FIR under Karnataka Forest Act 1963 Rule 24 (g) & (gg). In the meantime, The Deputy Conservator of Forests Ghataprabha Division, Gokak, vide Ref (2) letter dated 18-12-2021 stated that the User Agency had carried out the work with installing pipes in 2020 without obtain prior approval under section 2 of Forest (Conservation) Act, 1980.

Therefore, you are directed to verify the status of FIR booked against user agency and whether concerned authority had taken any necessary action against user Agency for violating Forest (Conservation) Act, 1980 and submit the factual report with specific remarks to this office at the earliest for further processing the proposal.
