Attention of the Conservator of Forests is invited to the references cited.

On the forest clearance proposal forwarded for diversion of 0.063 ha of forest land for laying of underground Optical Fiber Cable along the road side of Vellore-Odugathur Road across Pallikonda RF Vellore District in favour of M/s Telesonic Networks Limited, Mylapore Chennai, Government in the reference 5th cited above has called for clarification/additional details on the proposal as detailed

below and forwarded through parivesh portal vide Principal Chief Conservator of Forests reference 6th cited above.

a) The District Forest Officer, Vellore Division in his site Inspection report has stated that the User Agency, Telesonic Network Limited has proposed to lay the Underground Optical Fibre Cable along the State Highways Road, which passes through the Pallikonda Reserved Forest to a stretch of 1.050 Km, Hence, it may be clarified whether any forest land were already diverted to State Highways, if so send the details of earlier diversion.

b) Whether the present proposal of Telesonic Network Limited for diversion of 0.063 ha of Forest land in Pallikonda Reserved Forest may be considered under the category of Re-diversion, if the land was already diverted to State Highways Department.

The District Forest Officer has not reported the following details.

i) Whether any right of way allowed in the forest block notification. If so, furnish the details.

ii) What is the width allowed in the forest block notification and present length and width of State Highways road (BT surface, side berms, drains etc.,) in the forest area.

iii) Whether the State Highways has obtained any orders from the Forest Department for formation of road in the forest area.

iv) Evidence of road formed before the enactment of Forest Conservation Act, 1980.

Further, attention is invited to Para 4.2 of Consolidated Guidelines and Clarification (dated 29.12.2023) issued under Van (Sanrakshan Evam Samvardhan) Adhinyam 1980 and Van (Sanrakshan Evam Samvardhan) Rules 2023 by the Government of India.

In para 4.2 of Consolidated Guidelines issued by the Government of India, General approval is accorded in the forest land and located in the existing Right of Way (RoW) of roads which have already been allowed for non-forestry use for laying of OFC cables (both underground and above ground), telephone lines

involving trench size not more than two meter in depth and one meter in width and the State Government already authorised the Nodal Officer in this regard.

The District Forest Officer may be informed to analyse the proposal in depth and ensure that, if the laying of aerial OFC is proposed in the forest land and located in the existing Right of Way (RoW) of roads which have already been allowed for non-forestry use, then the user agency may be informed to furnish proposal under Form-E of re-diversion of forest area.


