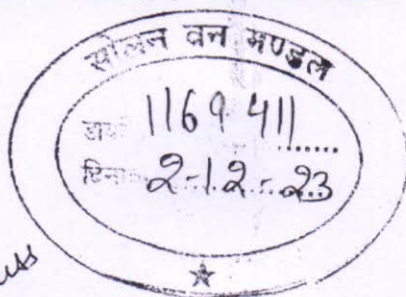

2. The following shortcomings have been noticed which may be attended to in all respect:-

1. Reply of point No.1 cannot be accepted, detailed report in view of the para 1.21 (i) and (ii) of FCA Guidelines be submitted.
2. The proposal KML file was submitted to GIS cell of Forest Department and as per data available with GIS cell the proposed area falls within or Eco sensitive Zone of Chail WLS. Hence, distance of proposed area may be reviewed and reply of point No. 11 & 17 be submitted accordingly.
3. The KML file showing the ERow or PRow may be provided in polygon shape.
4. The length & Width of broken area and un- broken area is required to be uploaded in additional information in part-I.
5. The Muck dumping site is required to be marked in KML file in distinct colour. Even if the same is proposed on private land further the sale deed/NOC of local people/ Owner may be uploaded accordingly.
6. The detail of dumping has still not been provided under Para B2.4 of part-I.
7. The detail of component wise breakup and purpose wise breakup of proposed area showing Khasra No. wise forest area and non forest area is still not uploaded.

You are, therefore, once again requested to ensure the proper scrutiny of each point of the observations, so that reply could be submitted to GoI.
