उपरोक्त विषयान्तर्गत सन्दर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि राज्य सरकार के संदर्भित पत्र द्वारा इस कार्यालय के समसंख्यक ई०डी०एस० दिनांक 27.01.2020 का प्रतिउत्तर प्रेषित किया गया है जिसमें निम्निलिखित किमयां पाई गयी है:

- 1 With reference to the point no. 1 of this office EDS even dated 27.01.2020, the KML has not been corrected as desired. The alignment proposed for diversion is not seen in the KML and the whole area marked with a single polygon as a beneficiary village.
- 2. With reference to the point no. 2 of this office EDS even dated 27.01.2020, no details related to alternate alignment explored is provided. The detail justification with proper comparisons and maps etc. may be provided by the state govt. to this office in this regard.
- 3. Regarding point no. 6 of this office EDS even dated 27.01.2020, it is provided that RO has visited the site again and found the area suitable for CA. As 8 ha has been found as MDF as per DSS analysis, DFO should personally visit the area and submit the report about its suitability for plantation.
- 4. Regarding point no. 7 of this office EDS even dated 27.01.2020, the justification may be explained in view of existing norms of PMGSY for road connectivity alongwith the line diagram of the area. A copy of the guideline/circular may also be attached.
- 5. Regarding point no. 13 of this office EDS even dated 27.01.2020, as stated by the state govt. that average width comes 8.3446 mtr is forest and 6.9317 mtr in Private areas but as seen in the past the case used to submitted for width 5/7 for such roads. Therefore, the state govt. submit the justification in this regard.
- 6. Regarding point no. 13 of this office EDS even dated 27.01.2020, the clarification is not much elaborated and clear.
