Sub:- Proposal for diversion of 26.994 ha forest land for construction of Four Lane dedicated Coal Corridor from Bankibahal (Coal Mine) 0/00 Km to Bhedabahal (SH-10) 30/811 Km in the District of Sundargarh by Executive Engineer Sundargarh (R&B) Division, Sundargarh


In inviting a reference to your above cited memo on the captioned subject, this is to inform you that, on scrutiny of the diversion proposal, the following deficiencies are noticed.

1. UA has not signed the check lists.
2. Tree enumeration differs in non-forest Government and non-forest Private land in Site Inspection Report and general abstract of trees.
3. CA Scheme is to be revised at current wage rate of Rs.298/- per MD.
4. KML/ Shape file of CA land not furnished.
- 5.(a) In the Form-A (Part-I), it is mentioned that the total non-forest land required for the project is 119.52 ha. **(Page No.11/DP)**
(b) Further, in Form-A (Part-I), the village wise break-up of non-forest land is 116.287 ha.
(c) In Page No.12/DP, the purpose wise break-up of non-forest land is 119.4972 ha.
(d) The total of non-forest land at Page No.59 to 163/DP comes to 115.958 ha.
(e) The status of coal bearing area of Basundhara Coal Field area of MCL over 4.30 ha involved this project as on 25.10.1980 may pleased be furnished.
6. NoC from MCL should be obtained to use 4.30 ha of non-forest land for construction of the road.

In view of the above, the diversion proposal in four sets are returned herewith to comply the deficiencies as pointed out above and resubmit the same to this office for early processing of the proposal.

This is urgent.
