**MINUTES OF THE FORTNIGHTLY REGIONAL COORDINATION
MEETING (FRCM) OF REGIONAL OFFICE, MoEF&CC, DEHRADUN
HELD ON 22nd NOVEMBER, 2024**

वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 तथा वन (संरक्षण एवं संवर्धन) नियम, 2023 के तहत वन भूमि प्रत्यावर्तन से संबंधित लंबित प्रस्तावों पर चर्चा करने हेतु पाक्षिक क्षेत्रीय समन्वय बैठक (FRCM) दिनांक 22 नवम्बर, 2024 को पूर्वाह्न 11:00 बजे श्री श्रीमति नीलिमा शाह (भा०व०से०), सहायक महानिरीक्षक वन (केन्द्रीय) की अध्यक्षता में क्षेत्रीय कार्यालय, पर्यावरण, वन एवं जलवायु परिवर्तन मंत्रालय, देहरादून में बैठक आयोजित की गई।

At the outset, Mrs. Neelima Shah, AIGF, welcomed all participants in the meeting and further forest diversion related matters/ proposals as desired/ proposed by the State Government/ Project Proponents were discussed in the meeting:

Agenda Item No. 01:

Diversion of 0.2275 ha of Forest Land for Construction of Toona Bauntha Motor Road to Barsu Motor Road in favour of PWD within the jurisdiction of Rudraprayag Forest Division, District Rudraprayag, Uttarakhand. (Online no. FP/UK/ROAD/149024/2021).

The proposal was discussed with the User Agency and the DFO, Rudraprayag Forest Division. It was noted that EDS on 4 points has already been raised in the proposal on 16.03.2023 reply to which has been submitted vide letter dated 14.06.2024 received online on Parivesh portal on 27.08.2024. On perusal of reply it was seen that the reply to only two points have been submitted.

After detailed discussion, it was decided that the complete reply to following four points raised in EDS dated 16.03.2023 shall be submitted by the State Government:

- 1) The beneficiary village is already situated along an existing road. Therefore, the State Government is requested to provide the path distance of the village (which marks the endpoint of the proposed road) from the nearest existing road and justify this proposal in accordance with the relevant norms.
- 2) If the proposed road is intended to connect to a location deep within the village then as recommended by the DFO the proposal be revised to a 3-meter-wide jeep road.
- 3) The details of the saplings that are proposed to be affected in the project, as outlines in paragraph 4 of Part-II and the Tree enumeration list, have not been provided. Therefore, the State Government is requested to provide these details.
- 4) The State Government is requested to submit a plantation scheme for planting 455 plants in 0.455 ha. This scheme should include all necessary details such as a KML file, digital map, and so on.

Agenda Item No. 02:

Diversion of 0.963 ha of forest land for Construction of Bhatrojkhan Nigrali-Bhikiyasain Motor Road in favour of PWD within the jurisdiction of Almora Forest Division, district Almora, Uttarakhand. (Online No. FP/UK/ROAD/11260/2015).

The proposal was discussed with the DFO, Almora Forest Division and Project Proponent. The User Agency informed that the proposed road is a missing link for the existing roads and it is necessary to construct this road to provide connectivity between the Block office and remote villages. However, DFO, Almora Forest Division submitted that the villages are already connected with the existing road and there is no need of the proposed road alignment.

After detailed discussion, it was decided that the proposed road is not required, as the villages are already seen connected with the road.
