महोदय,

उपरोक्त विषयक संदर्भित पत्रों के संबंध में अधोहस्ताक्षरी को यह सूचित करने का निर्देश हुआ है कि प्रस्ताव से संबंधित आर.ई.सी. बैठक दिनांक 11/12/2023 को आयोजित की गयी । बैठक में लिये गये निर्णय एवं कार्यवृत्त दिनांक 21/12/2023 (संदिभित पत्र-2) अनुसार अन्य वांछित जानकारी/स्पष्टीकरण की आवश्यकता है जो कि निम्नलिखित है:-

The area proposed for mining is 2.21 ha including safety zone and the other ancillary activities. Therefore, necessary correction in online Part-I are also required to be done.

- The safety zone has been marked on one side of the mining area, whereas as per the guidelines, the same should be marked inside all around (peripheral) the proposed area (i.e. 2.21 ha) with a width of 7.5 meters. This needs to be complied.
- Due to non-suitability of non forest land for planting trees @ 1000 trees per hectare the degraded forest land of 12.50 ha (out of 15.00 ha) has been proposed to plant balance number of seedlings for the said proposal. The State Govt may provide/upload the maps, KML etc for the same in online portal.
- The Lol uploaded in online portal was issued in the year 2021, whose validity was for 6 months which has already lapsed. Accordingly, a fresh Lol or allotment order shall be submitted/uploaded.
- In compliance to the guidelines in the Handbook of FCA 1980, whenever a proposal for fresh mining is submitted, a brief profile of the lessee/company should be submitted giving details of their existing mining leases in the State with their capacity of production, the present level of average annual production, location of these pits and the status of reclamation of forest land that have exhausted minerals. Along with this, the State Government shall also submit details of all other mining leases for that particular mineral with their capacity and average annual production and projected future requirements. They should fully justify the necessity of opening new mining leases for that particular mineral.

- 5. The State Government may confirm that the proposed mining conforms to the DSR of the concerned districts (as per EMSMG-2020 of SGMG-2016) issued by Competent Authority.
- 6. In view of the fact that the proposal involves felling of 27 trees within 300m vicinity of a natural pond, 0.5% of project cost proportionate to the extent of forest land involved, shall be paid by the user agency, and the same shall be deposited into the CAMPA account. The State Government shall ensure details of the finalized SMC Plan, disposition of amount and payment of deficit amount, if any, etc., shall be approved by the competent authority and concurred by the RO Bhopal within a period of one year from the date of deposit of the said amount. The above details shall be submitted.
