In reference to the above mentioned Proposal received on the PARIVESH Portal at the level of the North Forest Division, it is informed that the site inspection of the Forest land proposed for diversion has been carried out by the undersigned on 23.12.2021. During the site visit, it has been found that the marking of all the trees proposed for felling under the FCA proposal is still not completed by the User Agency. Some trees which are standing in this FCA portion have not been enumerated on the ground.

It is also mentioned that details sought earlier from this office vide letter dated-14/12/2021 is still not submitted by the User Agency in proper format, which are as follows:

1. Details of non-forest land area identified for Compensatory afforestation viz. Survey No/Compartment No./Khasra No./Khatoni No., Village, Tehsil, District etc along with map.

2. Statement showing the details of Forest Area involved and item-wise break up of Forest area proposed for diversion in proper Format and duly signed by the

Competent Authority.

3. No objection Certificate (NOC) for Compensatory Afforestation land from Land Owning Agency that the land is encroachment and litigation free is mandatory and need to be submitted.

4. FRA Certificated from competent authority in the State that all the Forest rights under the Forest Rights Act, 2006 have been settled in respect of the Forest area proposed for diversion is mandatory and need to be submitted.

5. Detailed Muck Disposal Scheme need to be submitted in proper format.

Therefore, now in order to process your proposal, you are requested to submit the details mentioned above at the earliest, so that the proposal will be processed on time.

Sir,

In reference to the above mentioned Proposal received on the PARIVESH Portal at the level of the North Forest Division, it is informed that the site inspection of the non-forest land proposed for Compensatory Afforestation at Dhulsiras Village, Dwarka has been done by the officials of North Forest Division on 20.12.2021. But Officials from DMRC were not present during the inspection of the CA site. During the inspection of the CA site, it has been found that the area is under the active agriculture and Farming. It has also been found that the Compensatory Afforestation land is not clearly demarcated on the ground as per the forest area proposed for diversion in the above mentioned proposal.

Therefore, the User Agency must ensure that the land proposed for Compensatory Afforestation should be properly demarcated on the ground. User Agency also ensures that the CA land should be free from any encroachment and litigation, before it will be handed over to the Department of Forest and Wildlife for Compensatory Afforestation.
