Subject: Diversion of 12.23 ha of forest land in Hyderabad Division for laying of pipeline and construction of structures for Segment-7 under Telangana Drinking Water Supply Project in favour of Superintending Engineer, TDWSP Circle, Hyderabad - **additional information / documents required-reg.**

Sir,

Please refer to the subject and reference cited above. On examination of the subject proposal, the following discrepancies have been noticed and needs to be rectified;

1. Confirmation regarding uploading of list of trees enumerated in the table designated for the same in part II of the online FC application.
2. Original copy of the RoFR certificate or copy of the RoFR certificate duly attested with official seal of the concerned competent authority needs to be furnished.
3. The State Government has proposed 12.23 ha of non forest land for compensatory afforestation under the subject proposal as part of 187.677 ha of non forest land identified for entire TDWSP projects (Mission Bhageeratha Project). To supervise and monitor the CA land, State Government shall demarcate the 12.23 ha of non forest land with DGPS coordinates. The co-ordinates, map, CA scheme and soil suitability certificate etc shall be uploaded in the Ministry's web portal against the subject proposal and hard copies of the same needs to be furnished.

4. As per the GIS-DSS analysis some segments of the proposed forest area falls within 830 meters of the Chincholi Wildlife Sanctuary (Karnataka). So, the facts like whether the proposed area falls in WLS area on ground or Eco Sensitive Zone (ESZ) and if not falling under the proposed ESZ, whether the ESZ has been declared or not? etc may be verified and report on the same needs to be furnished.

Hence, I am hereby directed to request that the above mentioned discrepancies may be looked in to and compliance in this regard may be sent to this office at the earliest so as to place the proposal before the Regional Empowered Committee (REC) for further consideration.
