- 2. The State Govt, has identified notified degraded forest land for raising CA in lieu of forest land proposed for diversion. The Nodal Officer (FCA) has accepted the proposal on 09.02.2023, the provisions of Forest (Conservation) Rules, 2022 shall apply to the proposal. The exception given for Central Govt. agencies for CA over twice the degraded forest land is not applicable to the instant project, since the instant forest diversion proposal involves 16.503 ha of non-forest land for execution of the project. Therefore, State Govt. should identify equivalent non-forest land for raising CA and submit details CA Scheme with relevant Maps
- b. Earlier Ministry vide letter No.8-80/87-FC dated 08.09.1987 has accorded final forest. clearance for diversion of Wiss' na of forest land for construction of Koraput-Rayagada Railway line. The State Govt. has not furnished the status of compliance of stipulated
