
Sir,

Please refer to the State Government letter above on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. I am to inform that the proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder and proposal has been found deficient. The following additional information/documents are found lacking:

- 1) State Govt to furnish the action taken report on the person responsible for violation of Forest (Conservation) Act, 1980 as per para 1.21(i) on ex post facto approval penal provisions of handbook of Forest (Conservation) Act, 1980 and Forest Conservation Rules 2003 Guidelines.
- 2) The current status of mutation and transfer of the non forest land proposed for CA.
- 3) The clarification on density of tree cover of the proposed area as it is mentioned as 0.1 to 0.4 as per the DFO site inspection whereas in the Part II Form it is mentioned as 0.1.
- 4) The current status of F(R)Act, 2006 of this instant proposal.
- 5) The undertaking certificate for the payment of the proposed CA site.
- 6) State Govt to clarify whether electric transmission line also included in area under proposal and penal action taken, if any.

State Govt is requested to kindly furnish the above requisite information to this office for further processing of this proposal.
