Sir,

On receipt of the above mentioned proposal on Privesh Portal, this office has scrutinized the proposal and following discrepancies are observed:

1. DDA has allotted 25 Ha. land to DMRC for Compensatory Afforestation, Wherein DDA has given the details of Geo-coordinates only. (The User agency need to submitted land details like Khasra No. Village Name, Tehsil, District).
2. Survey sheet of India indicating Compensatory Afforestation land and Geo-referenced map of C.A land.
3. KML files of Diversion site/ Compensatory Afforestation site prepared with DGPS/TSM need to be submitted if submitted files are prepared with GPS only.
4. Muck disposal scheme with block diagram.
5. As the project alignment is passing through Eco-Sensitive Zone of Asola Bhati Wildlife Sanctuary in Tughlakabad region. Permission from National Board of Wildlife is required to be submitted.
6. Area calculation sheet for forest and non-forest land should include length and breadth of the alignment need to provided.
7. KML files of diversion site and compensatory afforestation site need to be submitted in this office in PEN Drive/CD.
8. You have submitted combined tree list for both division. You are requested to submit the trees list of west Division separately.
9. You have submitted undertaking for complete diversion of 11.16 Ha. forest land, However .32 Ha. land falls under the jurisdiction of West Forest Division(need to submit the undertakings for .32 Ha. only).
10. Project Sanction/Approval letter.

You are requested to upload the aforementioned documents on Privesh Portal and 4 copies in the office of undersigned so that proposal can be processed at earliest.

On receipt of the above mentioned proposal on Privesh Portal, Inspection of the site proposed to be diverted has been carried out by the official of this division and Undersigned along with DMRC official on 20/12/2021. Inspection of the site was carried as per the KML file uploaded on the Privesh Portal. During the inspection it has been observed that the proposed alignment is passing through many area where tree canopy cover is dense and trees standing in that area are not marked/numbered so that it can be decided whether this area is falls under the category of deemed forest or not.

Therefore, you are requested to mark all trees standing in contiguous patches of land after that a joint inspection shall be carried out to further process the proposal.


On receipt of the above mentioned proposal on Privesh Portal, Inspection of the site proposed to be diverted has been carried out by the official of this division and Undersigned along with DMRC official on 20/12/2021. The alignment of the proposal has been checked and found that few patches of land measuring .7096 Ha falls under notified forest and you have not applied for diversion of these land patches. The area calculation for this division also found erroneous. So that total figure of land need to be diverted is 1.04 Ha. for West Forest Division, however deemed forest shall be checked after the Numbering/Marking of trees of contiguous land patches.

You are requested to submit the reply of this office letter Dated 17/12/2021 & 21/12/2021 after that total land proposed to be diverted shall be calculated.
