Sub:- Compliance to the Forest Re-diversion proposal seeking prior approval of Central Government under section 2(ii) of the Forest (Conservation) Act, 1980 for re-diversion on 2.405 ha of already diverted forest land of existing water pipeline corridor for laying of Iron Ore Slurry Pipeline from Barbil to Angul.


With reference to the above cited correspondence on the subject, it is to inform that the Addl. Principal Chief Conservator of Forests, Forest Diversion & Nodal Officer, FC Act has returned the above forest diversion proposal vide his memo No. 9939 dt. 01.06.2019 with the following objections which may be complied immediately.

1. The Stage-I approval order of the MoEF vide letter F. No. 8-75/2008-FC dated 30.03.2010 of the diverted land (168.232 ha) has not been enclosed in the DP.
2. The UA has not furnished the compliances of the Stage-II approval order accorded by MoEF & CC vide letter F.No. 8-75/208-FC dated 28.10.2010.
3. The UA has not furnished the purpose wise break up of approved land use plan of already diverted forest land of 168.232 ha.
4. The UA has not furnished the purpose wise break-up of the proposed change in land use plan in the DP.
5. The UA has not enclosed the MAP of approved land use plan.
6. The UA has not furnished the map of proposed change in land use plan showing clearly on the approved land use plan.

In view of the above, the said forest diversion proposal received from the RCCF, Angul vide his memo No. 5028 dt. 18.12.2019 is returned herewith in 6(Six) sets to comply the deficiencies as pointed above and re-submit the same to this office for early processing of the proposal.
