The Chief Conservator of Forests (T), Pune vide letter dated 15/12/2022 has submitted proposal for diversion of 0.90 ha. forest land for up gradation of road SH-131 from Bhivari to Kanifnath Mandir at Bopgaon, Tal. - 2. Sub-Divisional Forest Office, Bhor the certificate no.12 no submitted proper format. The same to be submitted following format.

The non-forest area covered under the project is not under the provision of Maharashtra Private Forest (Acquisition) Act 1975 by virtue of application of Section 35 of Indian Forest Act 1927 and are not recognized as deemed reserved forest as well as not included in the area identified as "forest" as per dictionary meaning of forest as intimated to the expert committee appointed under interim judgment of the Hon'ble Supreme Court dated 12/12/1996.

- 3. Original notification of the reserved forest land to be submitted.
- 4. Copy of the administratively approval not enclosed along with proposal.
- 5. The typed CA suitability certificate to be provided in 3 copies.
- 6. FRA,2006 undertaking of User Agency to be submitted in 3 copies.
- 7. 3 alternative alignment KML file not submitted along with proposal.
- 8. To defray the cost of CA undertaking of User Agency not submitted along with proposal.

The above discrepancies should be complied to this office at the earliest.
